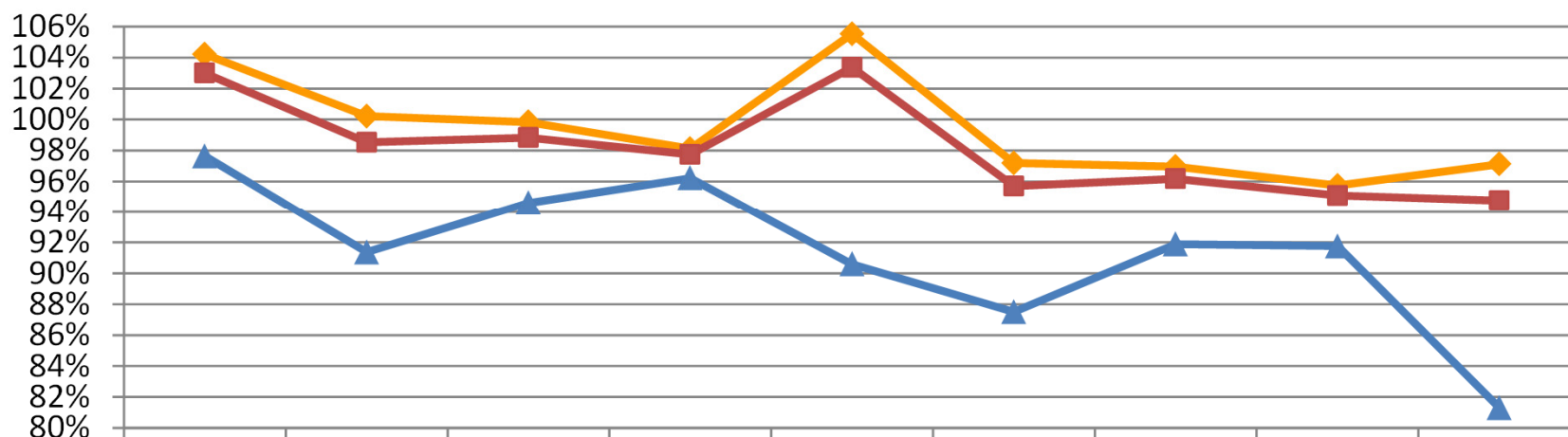
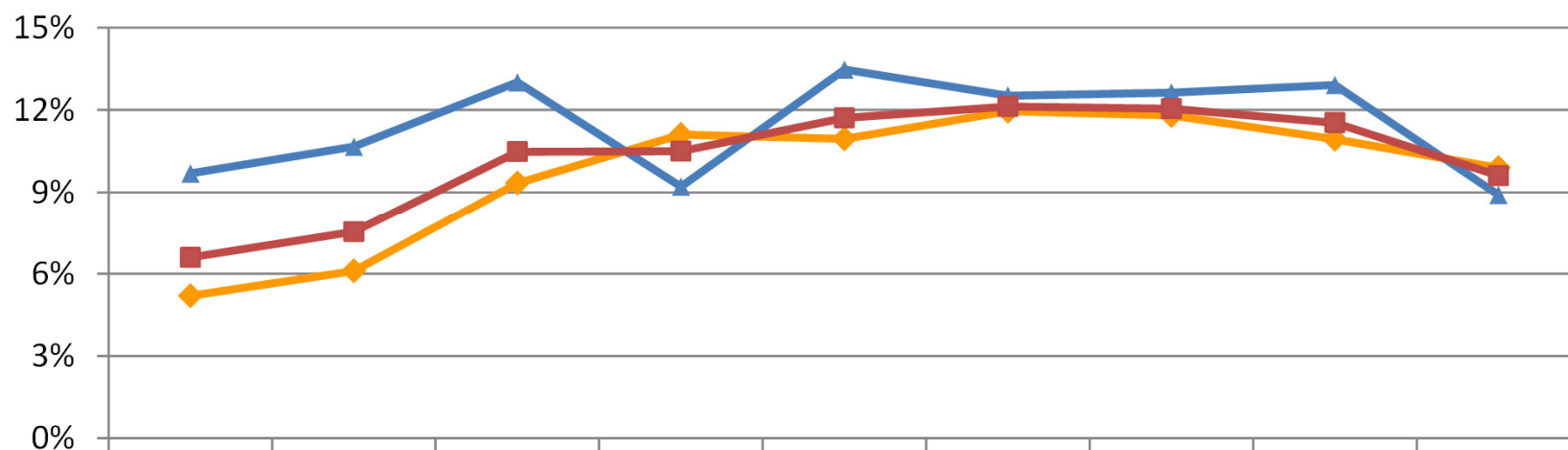

Return on Equity (ROE)



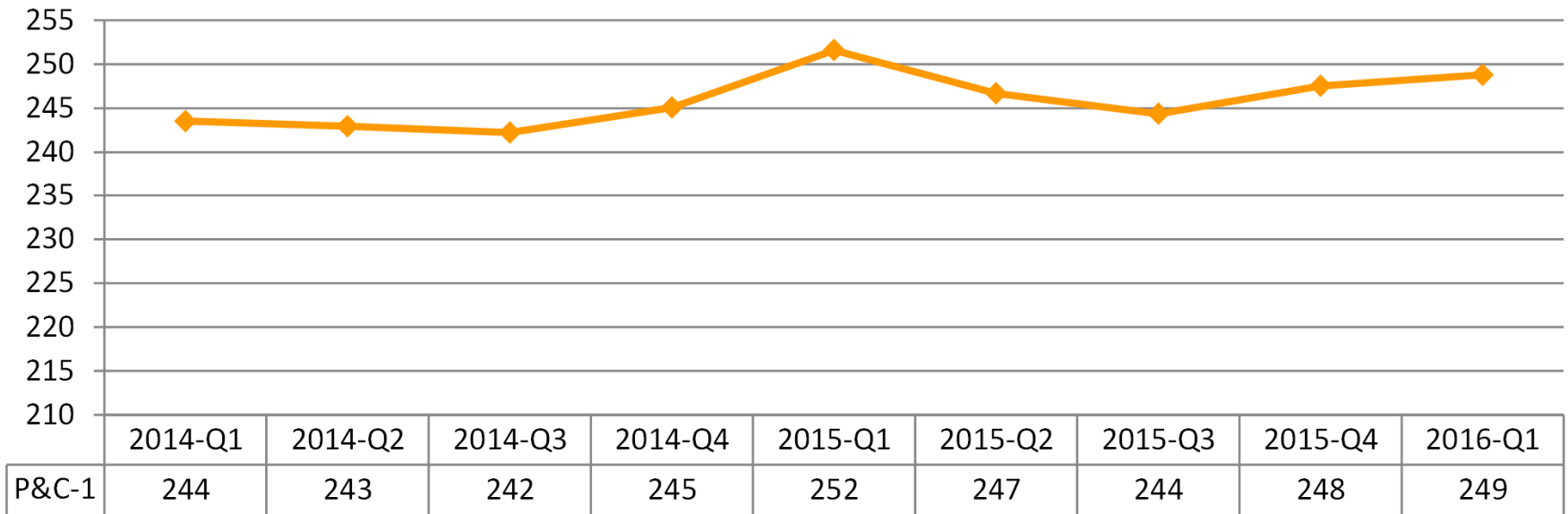

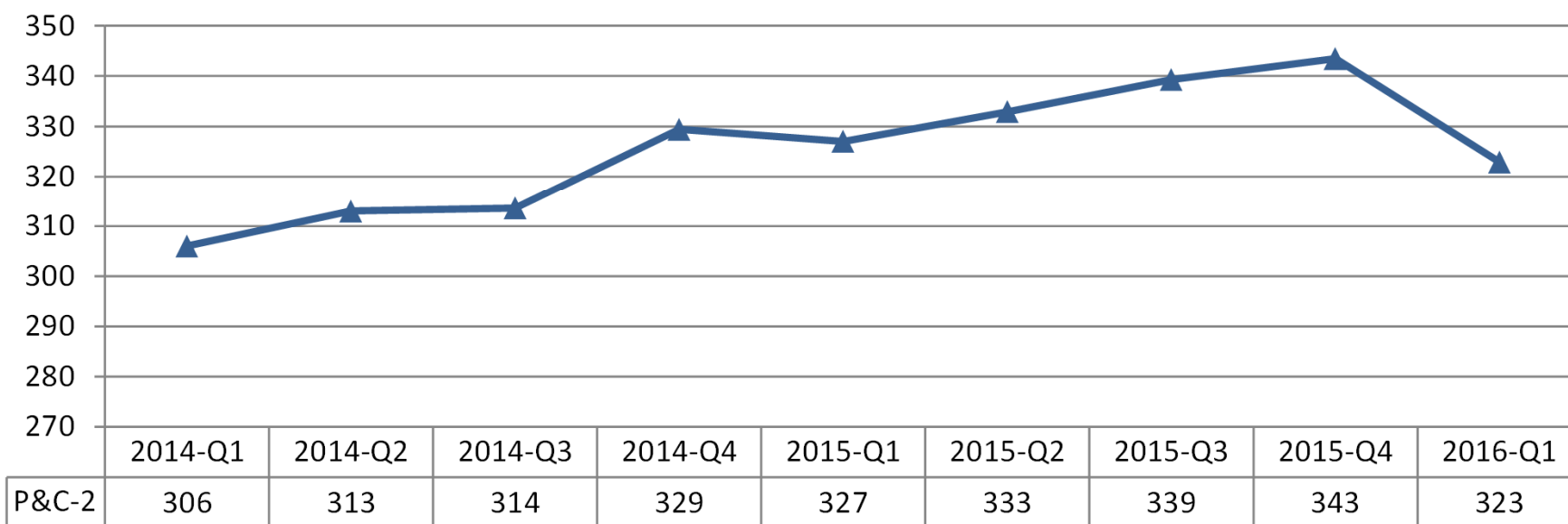
